

LOT PURCHASE with RIGHT TO INTER **for** **OCEANSIDE CEMETERY, NEW CASTLE, NH**

There are 3 basic lot sizes to purchase at Oceanside Cemetery:

1) Small Cremation Lots (4 ft. x 5 ft) \$600.00

These lots allow for four (4) cremations. These allow for monuments slightly raised above ground level (1 ft. wide x 2 ft. long) up to 4 inches high, OR an upright monument not to exceed 24 inches wide including the base x 36 inches high.

2) Traditional Half Lot (5 ft. x 10 ft.) \$1,000.00

These lots allow for one (1) traditional casket and up to (4) cremations on top of the casket. OR if all the burials are cremations, it allows for up to (8) cremations - a row of 4, two deep. An upright monument is allowed, not to exceed 36 inches wide (including base) x 42 inches high x 15 inches deep.

3) Traditional Full Lot (10 ft. x 10 ft.) \$2,000.00

This lot allows for two (2) traditional caskets and up to eight (8) cremations on top of the casket. Or, if all burials are cremations, it allows for twelve (12) cremations - three rows of four, one deep. An upright monument is allowed, not to exceed 60 inches wide (including base) x 42 inches high and 15 inches deep.

NOTE: The possibility of double stacking cremains and the stacking of cremains over casket burials will be determined by the size of the urns, soil conditions, and the available depth of the burial. If you want to insure there is no ledge and burial depth is sufficient for the types of burial, this can be done in advance, at your expense, by a third party that normally works with the New Castle Cemetery Trustees.

Purchase is the RIGHT TO INTER on the lot and it is not a deed. Ownership of the land remains with the Town of New Castle, NH. Lots are available to all current residents and former residents as detailed in the New Castle Cemetery Rules and Regulations document. Lot rights may not be resold, except the Town may buy back lot rights for the original price. Unused lots are subject to NH RSA 289:18.

Burials: We normally work with local funeral directors who are handling burial arrangements on behalf of the families. We sub-contract excavation to a contractor of our choice, with payment by the family either via the funeral home or direct to the subcontractor. Selection of a monument company is the family's choice and we can make recommendations if you wish. **No burials shall take place without notifying the Cemetery Trustees in advance and in writing.** Cemetery Trustees shall receive the death and cremation/burial certificate prior to burial.

Payment: Please make check made payable to "Town of New Castle, NH," and mail to "Cemetery Trustees," PO Box 367, New Castle, NH 03854.

Upon signing this Lot Purchase by a minimum of TWO members of the Cemetery Trustees, this document becomes the purchasers "Right to Inter" and shall be kept on file at the Town of New Castle.
