Burials: We normally work with local funeral directors who are handling burial arrangements on behalf of the families. We sub-contract excavation to a contractor of our choice, with payment by the family either via the funeral home or direct to the subcontractor. Selection of a monument company is the family's choice and we can make recommendations if you wish. No burials shall take place without notifying the Cemetery Trustees in advance and in writing. Cemetery Trustees shall receive the death and cremation/burial certificate prior to burial.

<u>Upon signing this Lot Purchase by a minimum of TWO members of the Cemetery Trustees, this</u> <u>document becomes the purchasers "Right to Inter"</u> and shall be kept on file at the Town of New Castle.
