

# **REGULATIONS FOR NEW CASTLE BEACHES, GREAT ISLAND COMMON, AND TOWN- OWNED PROPERTY**

## **BEACHES**

### **1. No Gatherings on New Castle Beaches After 9pm.**

There shall be no public gatherings on any public beaches within the town limits after 9pm.

### **2. Glass Prohibited.**

The use of glass bottles or containers shall be prohibited at all times. There shall be no littering of cans, bottles, or trash of any type permitted on any public beach at any time.

### **3. Alcoholic Beverages Prohibited.**

There shall be no alcoholic beverages sold or consumed on any public beach.

### **4. Boat Launching Prohibited.**

No boats will be allowed on any public beach.

There will be no boat launchings or boat landings by any boats except boats propelled by oars or paddles on the New Castle Town Beach.

#### **Definitions:**

1. BOAT - For the purpose of this regulation the term boat will include motorboats, sailboats, sailboards, and any type of jet skis.

2. TOWN BEACH - The Town Beach area will be from Ocean Street to the Common.

### **5. Dogs, Horses, and Other Domestic Animals on New Castle Town Beach.**

Leashed dogs under proper supervision shall be allowed on New Castle Town Beach for a trial period of May 16, 2014 to July 15, 2014, 6:00am-9:00am and 6:00pm-9:00pm. The beach shall refer to the area of sand and water, and permissible access to the beach shall be the areas designated as: 1. The "new passageway," running parallel to Beach Hill Road, and 2: Ocean Street.

Horses and other domestic animals shall not be allowed on New Castle Town Beach at any time.

### **6. Wheeled Vehicles Prohibited.**

There shall be no wheeled vehicles permitted on New Castle Town Beach with the exception of baby carriages, beach carts, and town maintenance vehicles.

## **7: Penalty.**

**Persons found guilty of violating any of the forgoing regulations shall be evicted from the New Castle Town Beach, and fined a maximum of (\$100.00) dollars.**

## **GREAT ISLAND COMMON**

Residents of the Town of New Castle shall be entitled to free use of the Common as are the guests of said residents when accompanied by their resident host. Non-Residents may enjoy the use of the Common at the discretion of the Select Board. Further, non-residents may obtain a Non-Resident Pass valid for one year upon payment of a fee, annually determined by the Select Board.

The following regulations apply to all Town property where so stated:

### **1. Great Island Common Open for Day Use Only.**

The Common is generally open to the public daily from 9am to 9pm. Special events may be authorized by the Select Board during other periods.

### **2. Speed Limit 10 mph and Parking.**

Auto traffic, which includes automobiles, motorcycles and bicycles, must obey posted signs, not exceed 10 mph, and park in designated areas only.

### **3. Charcoal and Propane Grills.**

No open fires are permitted. Charcoal and propane grills are permitted in designated picnic areas.

### **4. Domestic Animals Prohibited.**

No dogs or other domestic animals will be allowed in the Town Common Park from May 15 through September 15. From September 16 through May 14, all dogs and other pets must be kept on leash while in the Common.

### **5. Horseshoes, Lawn Darts, and Bounce Houses Prohibited.**

No horseshoes, lawn darts, or bounce houses are permitted on any Town property.

### **6. Alcoholic Beverages and Firearms Prohibited.**

No alcoholic beverages or firearms are permitted on any Town property.

### **7. Public Nudity Prohibited.**

No nudity shall be permitted on any Town property.

### **8. Fires and Fireworks Prohibited.**

There shall be no fires or fireworks permitted on any Town property.

**9. Metal Detectors and Excavation of Land Prohibited.**

The use of metal detectors is prohibited on all Town property as is the excavation of any land.

**10. Spear Guns Prohibited.**

Spear guns are not permitted on any Town property.

**11. Criminal Conduct Prohibited.**

All conduct or activity prohibited by the criminal statutes of the State of New Hampshire is prohibited on any Town property.

**12. Removal of Structure or Natural Features Prohibited.**

Removal of or damage to any structure, plant, shellfish, periwinkle or natural feature of the Great Island Common or New Castle Town Beach is prohibited.

**13: Penalty.**

Persons found guilty of violating any of the forgoing regulations will be evicted, and will be fined a maximum of (\$100.00) dollars.

**TOWN OWNED PROPERTY OTHER THAN BEACH AND COMMON AREAS:**

**1. All Domestic Animals Must Be Leashed at All Times Except on Town Landing.**

All domestic animals must be leashed when in all town parks or on other town property with the exception of the town-owned park located on Wentworth Road (former USCG land) commonly known as "Town Landing."

**2. No Domestic Animals Allowed in Town Buildings.**

No domestic animals will be allowed at any time in any town building.
