Scheduled Burials / Paperwork / Memorials

1. Martin Turmelle (Oceanside 46,8L) paperwork still pending regarding cremains that have been buried. (Remick Funeral Home)
2. John Robert Patterson (Riverside, section 1, lot 29) paperwork still pending. (Farrell Funeral Home)
3. Karen Trager (Oceanside) paperwork still pending, as is burial.
4. Allison Stebbins bench – family will order a 46" bench and will put it in between the two lots. No other upright stone on the remaining space is planned, so that is not an issue. They will have their daughter's marker (2' long by 1' wide by 4" thick) moved from Bedford Cemetery with her cremains to Oceanside 42, 6L&7.
5. Don White was buried September 9, 2020, Oceanside, 9,2. Veterans' flag & marker were added September 19, 2020.
6. A free-standing military medallion has been ordered by Linda Morrill for Morrill's grave from the VA, but whether it can be installed or not will be determined by the trustees.
