Final Cemetery Trustees Meeting Minutes

Burials / Paperwork / Memorials

Oceanside:

- 1. Trustees should have received Aiko Asano's death certificate and cremation certificate at town hall so she can be buried with Sam Asano.
- 2. Patricia S. Wise R3- Lot 4R (right side) half lot for a full burial, **May 1, 2021.** Death certificate is needed it could be at town hall at this time.
- Gail Martens would like to bury her niece's (Kara Sewall) cremains in R36, 7, a 10x10 lot. The niece died February 5, 2020. Seacoast Memorials advised that they are preparing a flat granite marker (12"x24") and a concrete vault for cremains (12"x12"). Martens will look for a 11:00 a.m. service on the soonest day Tim Griffin is available. She is looking at April 26, 28, 29, or May 6. Carol will look for the paperwork at town hall. (April 26 will likely be unavailable.)
- 4. Paul Schepis would like his lots, 11, 3 & 11,4, probed. Tim Griffin will do this on May 1. His daughter died five years ago and the family is seeking **July 14, 2021**, for the burial. Carol will meet him early July to determine and mark the location in the lot. He plans to put one central marker (1/2 on each lot) with the family name and then flat markers for the burials. Syphers is doing the monument. Death and cremation certificates will be provided.
- 5. Jeanne Menger is still scheduled for July 16, 2021, at noon, but we still need the paperwork.
- 6. Martha Whitney Steers (relative of Missy Wilich, (cremains) burial **date TBD** in 4,5. Seacoast Memorial is creating the monument which will be installed shortly.

Riverside:

- 1. Carol White met with Tim Griffin on Friday, April 23, to determine the burial location for Andrew White on May 8, 2021.
- 2. Charlene Petlick (cremains) burial is schedule for **July 12, 2021**, at 10:00 am, in the Julia White, #10 lot.

- 2. Patricia Gardner's application and check has been received for cremation lot 48,9. Trustees signed paperwork.
