

RESIDENT APPLICATION FOR RECREATIONAL BOAT/ RV STORAGE FORM

Full time residents of the Town of New Castle will be permitted to store their recreational boats or RV's in designated areas at the Great Island Common. No commercial boats may be stored. Boats/RVs may be brought in only after the application completed and fee paid plus confirmation to public work's employees. Proof of insurance and current registration are required. Checks payable to the "Town of New Castle."

1. Storage dates for Boats/RVs: The 2nd Saturday in September through the **1st day of June**.
2. Fees: \$6.00/foot. Boat-on-Trailer size: Minimum length - 15', maximum length - 45'.
3. All storage of Boats /RVs must have conformation from Public Works employees before storing. This conformation must be done during the workweek (Monday – Friday).
4. Maintenance: Repairs will be limited to minor maintenance ie: sanding, caulking, painting, cleaning and waxing. No overhauls are permitted.
5. Utilities: Electricity is available only seasonally.
6. Trash: Debris generated by owners during any maintenance must be removed by the owner.
7. Security: No security provided. Boat/RV storage is at the owner's risk.
8. Insurance: A copy of the Boat/RV insurance must be provided with the storage application.
9. Liability: Boat/RV owners must agree to bear full responsibility for their boats or RVs. Any damage caused in the moving of a boat or RV from fire, theft, vandalism or weather conditions is the full responsibility of the owners. The Town of New Castle assumes no responsibility for any damage that occurs to any boat or RV.
10. Fines: All boats/trailers, must be removed from the storage area by **June 1st**. Any boats or trailers remaining after the respective storage dates shall be fined \$100/day. All materials such as boat stanchions, stands, blocks, etc. must be removed at the same time. No exceptions.
11. The Town of New Castle reserves the right to restrict use of the current designated areas for Boat and RV storage and will authorize use on a YEARLY BASIS.
12. Failure to comply with any of the above regulations will result in the loss of privileges for future Storage.
