## Article 2021-2022 Operating Budget 01

To see if the New Castle School District will vote to raise and appropriate the Budget Committee's recommended amount of \$2,267,887 (Two Million Two Hundred Sixty-Seven Thousand Eight Hundred Eighty-Seven Dollars) for the support of schools, for the payment of salaries for the school district officials and agents, and for the payment for the statutory obligations of the District. This article does not include appropriations contained in special or individual articles addressed separately. (Majority vote required.)

(NOTE: This warrant article [operating budget] does not include appropriations in ANY other warrant article.)

The New Castle School Board recommends this operating budget. (Vote 3-0)

### Article New Castle Association of Coastal Teachers 02

To see if the New Castle School District will vote to approve the cost items included in the collective bargaining agreement reached between the New Castle School Board and the Association of Coastal Teachers/New Castle which calls for the following increases in salaries and benefits at the current staffing level:

Fiscal Year Estimated Increase 2021-2022 \$21,691

and further to raise and appropriate \$21,691 for the current fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at current staffing levels. Recommendations required.

## Article Building and Grounds Trust Fund 05

To see if the New Castle School District will vote to raise and appropriate the sum of 10,000 (Ten Thousand Dollars) to be added to the Buildings and Grounds Expendable Trust previously established. (Majority vote required.)
