RESIDENT STICKERS

Next year residents will have the option of mailing in a copy of their car registration, along with a self-addressed stamped envelope, to obtain their resident stickers. As a reminder, residents are allowed up to three stickers per household but the vehicles must be registered in the Town of New Castle. Non-residents property owners are entitled to one sticker for their vehicle.

SUPERVISORS OF THE CHECKLIST

The Town Election was held on May 8, 2012 with a total of 161 votes cast. The voter turnout was light since most of the offices were uncontested. Karen Mitchell was elected as a Supervisor of the Checklist replacing Mary Rauh. Mary has served admirably for the last 6 years and a big Thank You is in order not only from the rest of the Supervisors but also from New Castle residents. NEXT SUPERVISORS SESSION

The next Supervisors Session will be held September 4, 2012 from 7 to 7:30 PM at the Town Hall. This will be a time for new voters to register. A photo ID is required to register along with proof of New Castle residency. This may be a lease, electric bill, or car registration that shows your street address (NOT PO BOX). Party change is not permitted before the STATE PRIMARY WHICH IS SEPTEMBER 11, 2012.

HOUSE NUMBERS

Voters at the 2012 Town Meeting unanimously approved the adoption of "easily visible and readable" house numbers, so that medical, fire, police or other emergency personnel can quickly identify any residence in the Town. The numbers must be affixed in such a way that emergency personnel approaching a residence can quickly identify the residence as being the correct one. Those who need to change their house numbers to be in compliance with this new ordinance should do so by the end of this year. After 12/31/2012, violators may be fined up to \$25 per day for noncompliance. Please contact the Fire Department at 436-1132 if you require any assistance in the proper location of house numbers.

Note: As part of the new "911 Mapping" process, there is a possibility of about 50 properties being required to either re-number their buildings or change their street addresses (new street names a possibility). Emergency Management Director Dave Blanding and Building Inspector Don Graves are working on this and expect to present tasks and timelines at a future Select Board meeting.

NEW CASTLE DEPARTMENT OF PUBLIC WORKS

As you know, the City of Portsmouth has expressed interest in acquiring the New Castle Water and Sewer system in its entirety. One of the first steps in structuring possible transaction is to provide information requested by Portsmouth about the Town's water and sewer infrastructure. That information is being gathered by a committee chaired by Normand Houle, a New Castle DPW member. Additional tasks regarding this conveyance are being identified and will be in process shortly.

The Town welcomes any comments from residents about a possible transfer which can be addressed at the monthly New Castle Public Works Meeting, 2nd Wednesday of the month at 3pm at the Town Hall.

SEWER INCREASE

The City of Portsmouth has advised the Town of New Castle that the sewer rate for the Town has increased. The rate for New Castle residents, which includes the Town's infrastructure charge will be \$11.62 per unit. That increase raises the sewer charge for the minimum of 20 units to \$232.40. Portsmouth has also announced that there will be no increase in water fees this fiscal year.

Please be advised that increases in water and sewer charges are a major concern for the Town and that Town officials are taking steps to address this issue.

WATER LEAKS

Even though water usage fees will remain unchanged for New Castle residents this fiscal year, the cost of water, generally, continues to increase. It is important, therefore, that you have no dripping faucets or leaking toilets. There are FREE dye tablets at the Town Hall that you can use to check if your toilets are leaking. Small leaks in toilets can add up to gallons of wasted water!

SECOND WATER METERS

Now, more than ever, if you are watering your lawn or garden, washing a car or using water for other outdoor uses, please consider installing a 2nd water meter. Since water meter readings also determine sewer usage charges, any flow through the 2nd water meter would essentially not enter the sewer system and your sewer charges would be reduced.

Conservation of water for all uses is key to keeping your water and sewer bill as low as possible. Do only full loads in your washing machine and dishwasher. Turn off the faucet while brushing your teeth. Use a restricted flow shower head. Change the rubber rings or washers on any faucet that drips. Install new washers at the ends of hoses when you first connect them for the season. Use rain barrels wherever possible to water your garden.

The New Castle Historical Society launched into spring/summer with a full slate of projects and programs. An overwhelming crowd attended Neil Novello's program about the Portsmouth Naval Prison in April. We had to turn away more people than we seated. We did a repeat performance of the Naval Prison on May 15th for those who missed it. On May 29th, Bill Hall presented a program on his wife Emily's ancestor, Joe Cilley, New Hampshire patriot, raised on the Isles of Shoals, and a member of the militia that stormed Fort Constitution in the first overt act of the Revolution.

Laurie Clark and Elaine Nollet are redesigning our historical cases. Marj Smith is busy making the grounds beautiful and preparing for spring planting. Deb Soule and Jane Sweeney are scheduling oral history recordings. Nancy McArdle has put together a comprehensive membership data base.

We have acquired a new computer and a new past perfect data base, to enable us to upgrade storage and access our photos and documents. New lighting makes our panels easier to read and light up our cases. The old computer and monitor will be given over to programs for the public. Jim Cerny will install the new computer and work on creating a web presence for the resources that we have.

A scouting party sought out a Reverend Jordan memorial plaque, which was brought to our attention by a member of the Reverend Jordan Society, Jordan being one of our first ministers. We found it between the Coast Guard housing and Walbach Tower, presumably where the Reverend Jordan lived.

The Historical Museum will be open 3 days a week, starting, in May, Monday, Wednesday and Friday, 1 - 4pm. Looking forward to seeing you there.

New Voter ID Laws

The state of NH passed new voter ID laws that require citizens to provide photo IDs before they can vote in elections. The following explanatory document from the Secretary of State's Office (sos.nh.gov) is included here to help you understand the new laws as they now stand. Some parts of the new laws are under review by the Federal Government and may be changed by the time of the elections.

State of New Hampshire Voter ID Law - Chapter 284 - Explanatory Document

During the 2012 legislative session the legislature passed Senate Bill 289, also known as the "Voter ID" Law. The new law will phase-in a photo identification requirement over a period of time.

What type of photo ID will I need in order to vote?

- For any election *before* Sept. 1, 2013, you will be asked to provide one of the following:
- Driver's license issued by any state (even if expired);
- ID card issued by NH DMV (Division of Motor Vehicles);
- U.S. Armed Services ID card;
- U.S. Passport (even if expired);
- Valid photo ID card issued by either the federal government or a state, county or municipal government;
- Valid student ID card
- Other photo ID deemed legitimate by the supervisors of the checklist, the moderator, or the clerk; or

• Verification of identity by a supervisor of the checklist, the moderator or the clerk.

What if I do not have an approved photo ID?

- Before November 1, 2012, any voter who does not present an approved photo ID will be informed of the new law and permitted to vote.
- Between November 1, 2012 and September 1, 2013, any voter who does not present an approved photo ID will be permitted to vote after executing a "challenged voter affidavit."
- A voter who does not have an approved photo ID may obtain a free photo ID for voting purposes only by presenting a voucher from their town/city clerk or the Secretary of State to any NH DMV office that issues identification.

(NOTE: the State has not provided vouchers nor put the procedure into practice as of the time this document was prepared as this part of the law is under review by the FED. – Priscilla Hodgkins, Town Clerk – July 25, 2012.)

Is there any post-election action required by me after I vote without an approved photo ID? *After November 1, 2012*, if you filled out a "challenged voter affidavit" in order to vote on Election Day, you will receive a verification letter from the Secretary of State, requesting confirmation that you voted in the election.

If you do not respond in writing to the Secretary of State within 30 days of the date it was mailed, the Attorney General will conduct an investigation to determine whether fraudulent voting occurred.

STATE PRIMARY ELECTION, TUESDAY, SEPTEMBER 11, 2012

Recreation Center, 130 Wentworth Road Polls open at 9:00 a.m. and close at 7:00 p.m.

In order to vote in the primary voters must have declared a party affiliation. Voters have the option to change their party affiliation when they check-in to vote on September 11. This designation may be changed after casting ballots by submitting another form provided by the Supervisors of the Checklist. The deadline to change or declare a party affiliation before Election Day was June 5. In other words, you may not change your party affiliation between now and September 10, but you may do so on Election Day.

IMPORTANT DATES:

REGISTER TO VOTE – no later than September 4 (Supervisors of the Checklist will hold open office hours 7:00-7:30 p.m. at Town Hall) or on Election Day.

ABSENTEE BALLOTS must be received by 5:00 p.m. on Election Day.

GENERAL ELECTION, TUESDAY, NOVEMBER 6, 2012

Recreation Center, 130 Wentworth Road. Polls open at 9:00 a.m. and close at 7:00 p.m.

IMPORTANT DATES:

REGISTER TO VOTE – no later than October 27 (Supervisors of the Checklist will hold open office hours 11:00 – 11:30 a.m. at Town Hall) or on Election Day. ABSENTEE BALLOTS must be received by 5:00 p.m. on Election Day.

ABSENTEE BALLOTS – For voters who cannot be present on Election Day. Please note: Applications may be mailed in or submitted in person by the voter.

- Absentee Ballot Applications are available on line at http://sos.nh.gov/ and at the Town Clerk's office. Voters may mail these to the Clerk or may present the application in person.
- The Town Clerk's office will be open between 3:00 and 5:00 p.m. on September 10 and November 5 to accept last-minute applications in addition to regular public office hours. Applications will not be accepted in person after this time.
- PRIMARY ELECTION: If your party affiliation is "undeclared" you must indicate a party affiliation on the Absentee Ballot Application Form. If you are an "undeclared" voter and you do not stipulate a party, your ballot will be rejected.
- If you are already affiliated with a party, but wish to change party affiliation, indicate this on the Absentee Ballot Application Form.
- If you wish to change your party affiliation after the balloting, you may do so by filing a form with the Supervisors of the Checklist. Forms are available in the Town Clerk's office throughout the year and on Election Day at the polls.
