Presidential Primary: 2016

The primary has yet to be scheduled (at the time I am writing this) though some very smart people are predicting it will be held on February 9. A notice will be posted at the Town Hall and on the town's website after we hear from SOS.

New Hampshire primaries are based on party affiliation. If you are an "undeclared" voter you will be asked to select a party when you check in at the polls. You may return to "undeclared" status after you vote by filling out a form which the Supervisors of the Checklist will provide. If you are affiliated with a party and want to switch parties before you vote and switch back there is a similar process, however you must declare your party affiliation change with the Supervisors of the Checklist about the time nominations for office are closed, at the end of October.

Voter Registration

You may register to vote with the Town Clerk (usual hours) or with the Supervisors of the Check list on dates that will be posted by the supervisors.

New twist to Voter ID Law: Smile for the Camera

The voter ID laws have changed since our last election. When you check in to vote you will be asked for a photo ID. If you do not have one but one of the election officials can vouch for you, you do not have to fill out the Voter

Challenge form. If election officials cannot vouch for your identity, then you will have to fill out the form and your photograph will be taken by the Moderator.

If you come to vote without a photo ID it's a good idea to put aside some extra time for having your picture taken.

Absentee Ballots

Fill out and return an absentee ballot request form to the Town Clerk. Please print clearly when filling in the address for receiving the ballot. Request forms will be available on line at the town's web site.

One nice change: immediate family members may now pick up and drop off absentee ballot request forms and ballots, provided the voter has filled out and signed an official form (available on-line) and the person delivering the ballot has an approved photo ID. Here's the official jargon:

The city or town clerk shall not accept an absentee ballot from a voter's spouse, parent, sibling or child unless the family member completes a form provided by the secretary of state and the voter's spouse, parent, sibling or child presents a government-issued photo identification or has his or her identity verified by the city or town clerk.

If you are not an immediate family member as described above, you may pick up a request form for another voter but you may not receive a ballot nor bring one in.

Last day to accept absentee ballots in person is the day before the election between 3 and 5 pm. Absentee ballots sent by mail must be received at the post office before it closes on the day of the election

Voters may drop off an absentee ballot request form and receive the ballots in person, once they are available, and they may receive and send them via mail or bring them to the office in person.

Domicile and Non-resident Vehicles

Voter laws were recently changed to strengthen the requirements for identification and determination of domicile. Legal domicile in New Castle is a requirement for registering to vote here. Many New Castle home owners spend part of the year in other states. While they may spend roughly half the year here and half in, say, Florida, they must decide which state is their official domicile; there can only be one. Your domicile is where you put your head down to sleep for over 50% of the year and is the same place where you intend to reside. See definition and law below. *

Vehicle Status: If you are not domiciled in New Castle, N.H. the status of your vehicle registration should be *non-resident*. Vehicles with *non-resident* status may not be out of state overnight.

Examples:

- a.) You are registered to vote in another state, then the automobiles registered in your name in New Castle must have a status of *non-resident*.
- b.) You declared a homestead in Florida, which establishes your domicile in Florida and you are, therefore, not a resident (domiciled in) New Hampshire. You would vote in Florida and cars registered in New Hampshire must have a *non-residence* status.

Please note: I do not make up these laws.

*DOMICILE: A person must have a domicile in the town or ward in which he or she seeks to register. Supervisors may require proof of domicile in the form of an affidavit declaring that the applicant has a domicile in the town or ward in which he or she desires to vote. The determination of a person's domicile is a question of fact. Based on the available

evidence, is it more likely than not that the person has established a physical presence at the place claimed as domicile? If yes, it is more likely than not that the person has manifested an intent to maintain at that one place, more than any other place, a continuous presence for domestic, social, and civil purposes relevant to participating in democratic self-government. If yes, the person has satisfactorily proven his or her domicile for voting purposes. A voter's intention to reside and his or her actual physical presence must coincide. The mere fact that someone intends to make a town his domicile is insufficient. The person must actually have a physical presence there. A person can have only one domicile for voting purposes. A person's claim of domicile for voting purposes is not conclusive of the person's residence for any other legal purpose. RSA 654:1. (From New Hampshire Election Procedure Manual.)

Overseas Voters

UOCAVA (The Uniformed and Overseas Citizens Absentee Voting Act)

Any person who is <u>temporarily residing</u> outside the United States has the right to vote in the town or city in which he or she was domiciled immediately prior to his or her departure. Temporarily absent voters are eligible to vote for all offices. Voters residing overseas must register every year as their eligibility expires each December 31. As the Presidential Primary will take place very early in 2016 your 2015 registration will be accepted for this election. If you haven't yet registered in 2015, please do so very soon.

UOCAVA voters should use the Federal Post Card Application Form

UOCAVA voter may choose to have his or her
absentee ballot delivered either by mail or
electronic transmission (email). Absentee ballots for
UOCAVA voters are available 45 days prior to a
