NEW CASTLE HISTORIC DISTRICT COMMISSION

The NCHDC has undertaken a review of the policy, created in 2012, concerning installation of solar technologies in the historic district. The current policy can be found on the town website under the Historic District Commission and “Regulations.” The review is being done after several homeowners approached the NCHDC about installing this technology at their home. A draft of the new language is below. The biggest change removes language prohibiting this type of technology in the District if visible from the public way and allows the technology if it fits a series of criteria.

The NCHDC seeks public comment on this revision at its next 2 meetings on November 2nd and December 7th at 7:00pm. The Commission will vote on this policy once public comment has been heard and discussed.

Photovoltaic and Solar Thermal Regulations for the New Castle Historic District

Pursuant to the New Castle Zoning Ordinance 9.3.1 and in compliance with the Secretary of Interior’s Standards for Treatment of Historic Properties

(<https://www.nps.gov/tps/standards/re>

[habilitation/guidelines/solar-technology.htm](#)), applicants for photovoltaic (PV) and Solar Thermal (ST) systems in the New Castle Historic District should be aware that these systems can only be installed when there is little or no adverse impact on the physical or visual architectural landscape of the historic district. The homeowner should fully examine the site for its potential to accommodate these technologies to minimize impact on the District. The intent of these rules is to find a balance between solar technology and protection of the historic district. For existing buildings and new construction the following rules are established:

1. The appropriateness of a PV and ST system will be based upon the historic character and architectural significance of the individual structure and its relation to its surroundings.
2. PV or ST systems must be positioned in such a way as to have the least impact on the public view (streetscape).
3. All PV and ST installations must not replace original or historic features of the structure.
4. Systems should be on the same plane as the roof, with color of the panels in keeping

with the surrounding roofing materials. All plumbing, wiring and mounting hardware should be hidden

5. PV and ST installations need to be designed and positioned to be in scale with the structure's roof line, while maintaining a balance and scale with other features of that elevation.

Recommended Application Materials for Public Hearings

Applications for photovoltaic and solar thermal systems should include materials to adequately describe the proposed equipment, the structure and the surrounding area of the district. Submitted materials should include:

1. A sample of the product and supporting documentation
2. Photographs of the installation site and the surrounding area of the district from the public way (street views). Sketches or digital renderings should, illustrate the proposed installation of the array.
3. A scaled drawing of the proposed system that includes all supplemental equipment

as well as any proposed screening materials.

OPEN LETTER TO THE RESIDENTS OF NEW CASTLE

To All 1B Travelers:

It is time to re-establish the Safepath Fund. If you aren't familiar with Safepath, 20 years ago with great generosity and forethought, Phyllis and Howard Cosby put their beautiful land along Wentworth Road into a conservation easement to protect it from development. As part of the easement, they allowed for the creation of a sidewalk, which connected the sidewalks of the Wentworth to Wild Rose Lane. At that time, in addition to private donations, the town voted to pay for 20% of the cost of the Safepath. Federal and state funds paid the balance. The Safepath made a dangerous stretch of road much safer for pedestrians and bicyclists.

In the spirit of the Crosby Safepath project, we are proposing that the town of New Castle continue working with an engineering firm to design and implement a comprehensive ten-year plan for completion of the Safepath where possible. The work would be all along 1-B on Wentworth Road, Cranfield Street, and Portsmouth Avenue where possible. It is impossible to walk, run, or ride a bicycle any distance on Route 1-B in New Castle without going into the vehicle lanes. Some days, many of our children travel to school by bike competing with pickup trucks.

The design is going to require imagination and planning but waiting

for a tragic accident seems inexcusable. When we get started within a few months, we should be able to finish the Safepath from Wild Rose Lane to the Common. We estimate this cost at approximately \$30,000 of which at least half could come from existing town funds. We could also begin work on taking out the ledge between the two Shaw Roads along Wentworth Road.

These projects would be a public-private partnership. To help with this phase of Safepath, please consider making a donation to the New Castle Safepath Fund and contributions are tax deductible.

New Castle Light Emitting Diode (LED) Lighting Conversion Program

The Town of New Castle Select Board and the New Castle Energy Committee is in the process of reviewing and upgrading its street lights and determining how we can save money in the process. Over the past few years, many of our street lights have burned out. The replacement of these lights has sparked some interest in understanding the process and incentives for converting to LED lights.

Through this research process, we have learned there are multiple communities in New Hampshire and specifically nearby on the seacoast that have begun the conversion of their streetlights to LED. They are: Portsmouth, Hampton, Dover, Greenland, Newfields, Newmarket and several others around the state. The list of towns completing their conversion to LED is growing everyday. All of the towns have realized saving on their electricity bills and CO2 abatement with the LED lights. Street lighting is roughly 55-60% of the Town of New Castle's monthly electricity bill for all buildings. So while we may be a small town with a reasonably smaller electricity bill each month – we will save real money and as detailed below, we will pay for the conversion to LED lights in just 2.38 years.

In the process of reviewing local contractors that execute the LED lighting conversions, the New Castle Energy Committee was introduced to the local company Affinity LED Lighting of Dover, NH. Affinity LED Lighting presented to the Select Board and local residents on September 18, 2017. It was determined that we would proceed with two test LED lights which were installed on Main Street.

The LED test lights were installed at the intersection of Main St and Atkinson and Main St and Walbach Street. We decided to add two shields to the LED light on the corner of Main and Walbach Street, which reduces the back lighting on the nearby house. The LED test lights installed are 65 Watt and are a clear white light that will improve visibility in fog and in snow storms. The LED light is directed downward and is night sky friendly (with zero uplight).

The details of the LED Conversion Program from Affinity LED Lighting have been highlighted:

Total Cost is \$17,083 for converting 68 fixtures on your EOL ledger (avg. \$251.21 per fixture All-In, for equipment and all installation services.

All of the 68 proposed fixtures will be the S800 series cobraheads, assembled by US Veterans in a locally based UL certified manufacturing site in Dover, NH.

The Eversource Incentive is expected to be confirmed at \$6,800, which will result in a NET Cost after Incentive of \$10,283.

Estimated Annual Savings \$4,326 for the Town's 68 lights.

We estimate a Simple Payback of 2.38 years. This is Very Good

Simple payback = \$10,283 net / \$4,326 annual estimated savings = 2.38 years.

Cumulative Savings over 10 years = \$43,260 and cumulative Savings over the life of the fixtures (20 years) = \$86,520

Annual CO2 Abatement = -8.45 tons,
Cumulative over 10 years = -84.5 tons,
20 years = -168.9 tons

The Energy Committee strongly supports full conversion of all 68 street lights in New Castle. The Select Board has supported the test LED lights and the next step is to move forward with the remaining 66 lights. We encourage people to let the Select Board know they support full conversion to all LED street lights in New Castle. The Town will save Money by making this investment and it will also make a positive impact on our environment.

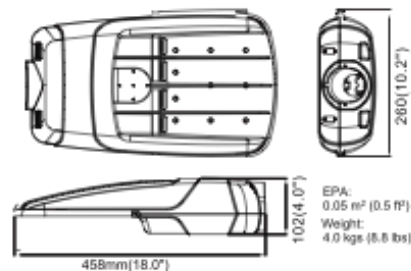

PROPERTY TAXES

At this time, the 2017 Tax Bills have been mailed out with a tax rate of \$5.85. Property Tax payment due Wednesday, December 6, 2017.

NEW VOTING LAWS

Senate Bill 3 (SB3) became law in August and September. There are several changes to voter registration and issues regarding residency and domicile, especially for voters who register within 30 days of an election.

You may read about the new voter laws here: <http://sos.nh.gov/Elections.aspx> Do find a comfortable chair and make yourself a cup of chamomile tea before reading these complicated/complex rules. Laws are made by our senators and representatives in Concord, not by Town Clerks, who would have made the laws comprehensible and less daunting.

DMV and VOTING LAWS

Domicile and Non-resident Vehicles

Voter laws were recently changed to strengthen the requirements for identification and determination of domicile. (See above and <http://sos.nh.gov/Elections.aspx>). Legal domicile in New Castle is a requirement for registering to vote here. Many New Castle home owners spend part of the year in other states. While they may spend roughly half the year here and half in, say, Florida, they must decide which state is their official domicile; there can only be one. Your domicile is where you put your head down to sleep for over 50% of the year and is the same place where you intend to reside. If you give false information regarding your domicile/residence when registering a vehicle or registering to vote there are heavy fines (up to \$5,000).

Vehicle Status: If you are not domiciled in New Castle, N.H. (not voting here) the status of your vehicle registration should be *NON-RESIDENT*. Vehicles with *non-resident* status may not be out of state overnight.

Examples:

- a.) You are registered to vote in another state, then the automobiles registered in your name in New Castle must have a status of *non-resident*.
- b.) You declared a homestead in Florida, which establishes your domicile in Florida and you are, therefore, not a resident (domiciled in) New Hampshire. You would vote in Florida and cars registered in New Hampshire must have a *non-residence* status.
