The following public sessions are scheduled to implement changes and corrections to the Voter Checklist as described.

# MARCH 26, 2024, 7:00-7:30 p.m., New Castle Town Hall

During this session reports of voter transfer, death or removal of names can be made to the Checklist of registered voters.

New voters may register at this time who possess — and present at the time of registration — proof of identity (photo ID), age, citizenship (birth certificate, passport, NOT driver's license) and verifiable proof of domicile (i.e., bank statement, utility bill, car registration, or lease/deed with street address, PO Box is not acceptable). Qualified applicants who do not possess proof of identity, age, and citizenship, or who do not bring proof with them, may sign an affidavit of attestation, and qualified applicants without proof of domicile may sign an affidavit attesting to their domicile in order to register.

Changes in party registrations may be accepted.

During this session reports of voter transfer, death or removal of names can be made to the Checklist of registered voters.

New voters may register at this time who possess — and present at the time of registration — proof of identity (photo ID), age, citizenship (birth certificate, passport, NOT driver's license) and verifiable proof of domicile (i.e., bank statement, utility bill, car registration, or lease/deed with street address, PO Box is not acceptable). Qualified applicants who do not possess proof of identity, age, and citizenship, or who do not bring proof with them, may sign an affidavit of attestation, and qualified applicants without proof of domicile may sign an affidavit attesting to their domicile in order to register.

No additions or corrections shall be made to the checklist after this session, until the Town election day on May 14, 2024 except as provided in RSA 659:12. RSA 654:8,II

## JUNE 4, 7:00-7:30 p.m., New Castle Town Hall

During this session reports of voter transfer, death or removal of names can be made to the Checklist of registered voters.

New voters may register at this time who possess — and present at the time of registration — proof of identity (photo ID), age, citizenship (birth certificate, passport, NOT driver's license) and verifiable proof of domicile (i.e., bank statement, utility bill, car registration, or lease/deed with street address, PO Box is not acceptable). Qualified applicants who do not possess proof of identity, age, and citizenship, or who do not bring proof with them, may sign an affidavit of attestation, and qualified applicants without proof of domicile may sign an affidavit attesting to their domicile in order to register. RSA 654:32

Last day for voters already registered to change or declare party affiliations for the **September 10, 2024 State Primary.** Only undeclared voters may declare a party on Primary election day. RSA 654:34

### SEPTEMBER 3, 2024 7:00-7:30 p.m., New Castle Town Hall

During this session reports of voter transfer, death or removal of names can be made to the Checklist of registered voters.

New voters may register at this time who possess — and present at the time of registration — proof of identity (photo ID), age, citizenship (birth certificate, passport, NOT driver's license) and verifiable proof of domicile (i.e., bank statement, utility bill, car registration, or lease/deed with street address, PO Box is not acceptable). Qualified applicants who do not possess proof of identity, age, and citizenship, or who do not bring proof with them, may sign an affidavit of attestation, and qualified applicants without proof of domicile may sign an affidavit attesting to their domicile in order to register.

No changes to party affiliation will be accepted. (Deadline for party affiliation change ahead of September 10 State Primary is June 4, 2024)

No additions or corrections shall be made to the checklist after this session, until State Primary election day on <u>September 10, 2024</u> except as provided in RSA 659:12. RSA 654:8,II

## OCTOBER 23, 7:00-7:30 p.m., New Castle Town Hall

During this session reports of voter transfer, death or removal of names can be made to the Checklist of registered voters.

New voters may register at this time who possess — and present at the time of registration — proof of identity (photo ID), age, citizenship (birth certificate, passport, NOT driver's license) and verifiable proof of domicile (i.e., bank statement, utility bill, car registration, or lease/deed with street address, PO Box is not acceptable). Qualified applicants who do not possess proof of identity, age, and citizenship, or who do not bring proof with them, may sign an affidavit of attestation, and qualified applicants without proof of domicile may sign an affidavit attesting to their domicile in order to register.

No additions or corrections shall be made to the checklist after this session, until State General election day on November 5, 2024 except as provided in RSA 659:12. RSA 654:8,II
