



## **ROUTE 1B UPDATE REGARDING THE 10-YEAR PLAN**

As many of you may know, the improvements to the Causeway and Route 1B to address the flooding problems have been included in the NH Dept of Transportation's 10-year plan (2025-2034). This is great news and a big step forward for this important project for the Town. However, the funding has not yet been approved, and there are several years between now and getting the project implemented.

So, it is very important that the residents of New Castle continue to lobby for the implementation of the plan.

One of the most important ways to do this is to attend the Governor's Advisory Council annual meetings on Intermodal Transportation. (GACIT). This is our opportunity to speak directly to the Governor's Council and lobby for funding of this key project – representatives from other Towns will be lobbying for the funds for their projects, so it is important that we speak up in support of the needed improvements to the Causeway/Rt. 1B.

It's not done, til it's done, and our attendance and voices matter. Two of the meetings are nearby (Kingston 9/13, and Greenland 10/19), so hopefully we can turn out in force, in person or virtually (by zoom)
